Report Summary

ON MARCH 13, 2016 AT APPROXIMATELY 1:54 A.M. THE PLYMOUTH COUNTY SHERIFF'S OFFICE STOPPED TO CHECK ON A VEHICLE SITTING ALONG THE ROADWAY ON HIGHWAY 3 JUST EAST OF NATURE AVENUE, IN WHICH IT WAS DETERMINED THE VEHICLE WAS UNOCCUPIED.
